MASTER OF ARTS MAJOR IN POLITICAL SCIENCE

PREREQUISITE COURSES: 6 UNITS

GS 500 - St. Thomas and Critical Thinking

As the philosophical foundation of Research Methodology, it is a study of the principles of skills in critical thinking according to St. Thomas Aquinas in the three areas of mental cognition: simple apprehension, judgment, and reasoning; and of common fallacies towards the acquisition of the art of argumentation.

GS 501 - Research Methodology

The student is introduced to research concepts relevant to political science. Discussions center on how to prepare a thesis emphasizing choice of title, statement of the problem, sources of data, analysis and evaluation of information gathered among others. Course output is a thesis proposal.

Core courses: 9 units

PS 601 - Democracy: Theory and Practice

This course deals on the evolution of the democratic thought, from the Graeco - Roman period down to contemporary times, and the diverse practices either applied or distinguished from the theoretical democracy.

PS 602 - Political Systems

A study of the contemporary major institutions of government among selected countries, including their interaction, using various conceptual approaches and systems analysis.

PS 603 - Political Culture

This course comprehends the particular ways in the distribution of political attitudes, values, feelings, information and skills of selected countries that manifest the effect of the aforementioned factors upon the political process.

PS 604 - Philippine Political Thought

This course traces the growth of Philippine political thought from the propaganda period to the post-people power revolution era.

PS 605 - Philosophy and Foundation of Public Administration

This dwells on the rationales and the fundamentals of effective management of organizational personnel and behavior for proper execution of policies and goals of government agencies and quasi-government offices.

PS 606 - Political Philosophy of St. Thomas Aguinas

This undertakes a sound understanding of the Thomistic thoughts on governance. law, and leadership vis-a-vis the avowed mission and vision in a given society.

SPECIALIZATION: 15 UNITS

PS 701 - Philippine Constitutional History

This course traces the evolution of the Philippine constitution; analyzes the events leading to constitutional reform of each given period.

PS 702 - Local Government and Special Laws

This gives premium to introduction and promulgation of special laws that are relevant to the effective delivery of services and delineation of powers devolving on the local government.

PS 703 - Philippine Culture

A study of the sets of belief, values, feelings and sentiments of the people in the Philippine setting and their effects on the governmental structure and operations; interaction among people of different cultural communities in their work relationship with the state government.

PS 704 - Geopolitics

In this course geography is used as a determinant of politics, state power, strategic importance and national influence.

PS 705 - International Law

A study of the nature, sources, and applications of treaties and alliances; the laws of war and neutrality; and the problems in the enforcement of international law.

PS 706 - The United Nations

It deals on the problems of World Peace as well as the study of the structure, power and functions of component organs, case studies of the resolutions of the Security Council and the General Assembly.

PS 707 - Political Economy

A study of the economic management of states, the theories and strategies of national development and the control of the economy through the master science and art of politics.

PS 708 - Principles of International Relations

A course which discusses the concepts and guiding principles in the conduct of international affairs and relations to achieve the avowed goals of sovereign countries in pursuing interdependence of nation states, and to realize the objectives of international organizations in their respective roles as actors in given international events and/or issues.

PS 709 - Comparative Political Systems

This focuses on the systematic study of international politics and institutions, the conduct of diplomacy and foreign policy, and impact of international affairs on policy development.

PS 710 - Climate Change and Risk Reduction Disaster Management

This delves on the causes and effects of changes in world's regional climate and how these impact management of disaster risk reduction and vice-versa.

PS 711 - Role of the Unites States of America (USA) in Asian Political and Strategic Perspectives.

It is an analytical study of the position of USA in the various relations among Asian nation-states, particularly in territorial claims.

PS 712 - Special Topics: National Security Administration
