### **About Us**

The Doctor of Philosophy in Health Research degree, providing foundational course program is an alternative track to acquiring a doctorate work focused on research and devoting more time to research proposal writing, implementation, publication, and presentation. This contrasts the traditional coursework-dissertation track of the Doctor of Philosophy program, which requires 50-60 units of course work followed by dissertation proposal, implementation, publication, and presentation.

The Doctor of Philosophy for Health Research is a doctorate program to be offered using blended learning and is operationalized under the UST Graduate School in collaboration with the International Centre for Allied Health Evidence of the University of South Australia.

Research supervision is by local faculty members as content experts and international faculty members as method experts. Full-time students can finish the program in 3 academic years.

### Admission Requirements

Have completed a Bachelor's degree in any health discipline and a Master's degree with a thesis component or a Medical Degree

For the non-medical applicants, a general weighted average not lower than 1.35 (92%) or A- in the master's program may be admitted to a Ph.D. program. For the medical applicants, a general weighted average not lower than 85%

## Admission Requirements

An entrance examination composed of an IQ test, psychological test, essay composition. (*To be scheduled after preliminary screening of documents*. *Entrance Exam Fee is Php 600*).

Have published at least one paper as the primary author from his/her master's thesis or residency program or as a professional in a reputable, peer-reviewed national or international journal

#### Research proposal composed of 1000 words

- 1. Title of proposed research project (max of 20 words)
- 2. Overall proposed research question (max of 50 words)
- 3. Aims of the proposed research (max of 100 words)
- 4. Short background why the proposed research must be undertaken (max of 300 words)
- 5. Methodology or plan of action (incl analysis) (max of 350 words)
- 6. Significance of the proposed research (max of 150 words)
- 7. Five key references relevant to your proposed research
- 8. Explain how your previous research equips you to undertake the proposed research (max of 150 words)
- 9. List of publications
- 10. Provide relevant employment, work experience, society or organization membership details to support your application (max of 1 page)
- 11. Proposed supervisor and note if supervisor has agreed to supervise you
- 12. Area where research will be conducted and information regarding feasibility of undertaking the research in this site (affiliation, collaboration, etc)
